COMMISSIONERS:

Vegetative cutting within 100 feet of the natural bank in the most sensitive area along the North River and its tributaries is one of the major concerns of the North River Commission: The vegetation growing on the property helps to stabilize the land. This area can be identified as - The landward edge of the salt or fresh water marsh. Where emergent wetland vegetation is present that require periodic flushing and input of salt, brackish or fresh water to survive. It also is the point at which the water's edge meets the land during the mean annual high tide. This is what identifies the "Natural Bank", not the muddy riverbank that many people define as the natural bank. In freshwater rivers, brooks and streams, it means the landward edge of the mean annual high water which usually occurs in the early spring. Defined in G. L. c. 131, s. 40.

All that is allowed to be cut 100 feet landward of the natural bank is a path not greater than 15 feet, to access the shore, with a limit of one per lot. For more information the Scenic and Recreational Protective Order for the North River located on our website www.nsrwa.org/NRC

North River Commission Terms

<u>Informal Discussion</u> - The Commission may want to discuss something that has happened within the corridor. Or if someone wants to know if a project needs a Request for Determination or Special Permit.

<u>Request for Determination</u> - A project within the Corridor that is allowed according to the Protective Order.

<u>Special Permit</u> - If a property has a structure on it that could not be built according to the Protective Order. This structure is non-conforming and will need a Special Permit to change it.

<u>Cease & Desist</u> - Is issued if there is a violation against the Protective Order, It is recorded with the Registry of Deeds on the property.

<u>Certificate of Compliance</u> - Issued upon satisfactory completion of a Special Permit as approved by the Commission.

<u>Asbuilt</u> - Is a Engineer signed plan of a finished project as approved by the Commission.
