## IMPORTANT RACE INFORMATION

All skill levels are invited to participate in the NSRWA's 28<sup>th</sup> Annual Great River Race – from novice to racer. Non-motorized vessels including canoes, kayaks and stand up paddle boards can participate in the race, piloted by people of all ages. (Participants 16 and under must be accompanied by an adult.) The race is fun, challenging and a great way for individuals or families to get out and enjoy the river! There is also the “Best Decorated Boat or Boater” division for the less serious, but creative paddler.

## START/FINISH

Registration begins at 9:00am and ends at 10:30am. The race begins at 11:00am. If not pre-registered, please arrive by 9:30am. The starting line is at the Bridge Street Canoe Launch in Norwell. The finish line is at the Washington Street Bridge (7.5 miles from the Launch). Take out is at the Hanover Canoe Launch.

## REGISTRATION

This year's Great River Race is \$55 for the first participant per craft. Each additional participant on the same craft is \$10. Each registration includes T-shirt and waiver fee. Day of race registration is \$60/\$15. Additional T-shirts will be available for purchase after the race. Day of race registration is \$60/\$15. All participants must have a signed waiver to participate in the race. Life jackets are required and must be worn throughout the race or you will be disqualified. In the event of a severe weather cancellation there will be no rain date or refund. See the categories below to determine in which category you will register. Make checks payable to NSRWA.

## END OF RACE TRANSPORTATION

Transportation will be offered, free of charge, from the take out point to the racers' vehicles after the race from 12:30-3:00pm.

## AWARDS CELEBRATION

After the race, join us as the fun continues at Luddam's Ford Park (just a short walk from the takeout). The party will start at 1:00pm with awards given at 2pm. Awards will be given in each category. There will be FREE hotdogs, music, kids activities, plus a FREE ice cream, IndieFerm beer (for those 21 and older) or Kombucha for participants.

## DIRECTIONS

### Starting Line - Bridge Street Canoe Launch in Norwell

From Route 3, exit 12: Follow Route 139 East to Mobil Gas Station. Turn left onto Union Street, and follow Union Street to the North River • From Route 3, Exit 13: Follow Route 53 North to Route 123. Follow Route 123 East through Norwell Center, turn right onto Bridge Street and follow to the North River.

### Take Out - Hanover Canoe Launch, at Indian Head Drive

From the Bridge Street Canoe Launch in Norwell, follow Bridge Street to Route 123. Turn left onto Route 123. Follow Route 123 for less than 1 mile. Bear left onto Dover Street, which leads onto River Street. Follow River Street through Hanover Four Corners to Route 53. Cross Route 53 onto Broadway. At the fork, bear left onto Elm Street. Follow Elm Street and take a left just before crossing stone bridge onto Indian Head Drive, then follow to end.

### To view the Finish Line - Washington Street Bridge

From the Bridge Street Canoe Launch in Norwell, follow Bridge Street to Route 123. Turn left onto Route 123. Follow Route 123 for less than 1 mile. Bear left onto Dover Street, which leads onto River Street. Follow River Street to Hanover Four Corners. Take a left onto Washington Street and follow to the North River.

### Awards Celebration

From the takeout at the Hanover Canoe Launch walk back up Indian Head Drive to Luddams Ford Park.
